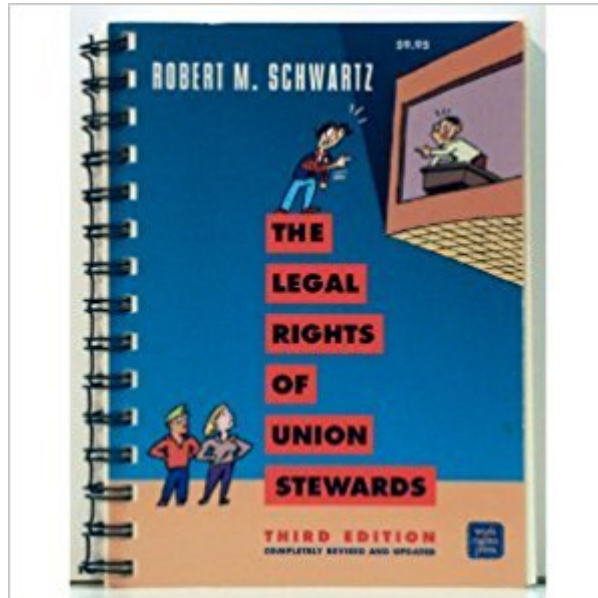

I bought this book hoping that it would be a handy guide to my rights and responsibilities as a Federal sector union steward. In it's first pages the book clearly stated that it shouldn't be relied upon by people in my position because many of the rights afforded to private sector stewards are derived from NLRB decisions. The NLRB has no authority in Federal employee labor issues so it's rulings are meaningless to folks in my position. It would be nice to have this book adapted to a wider audience or a separate book by the author to provide more information for public sector and specifically federal stewards.

It is well written and easy to read, It should be considered a MUST HAVE for every shop steward.

I feel this book is a must for all union representatives. It includes important information and also provides real-life situations as well as how they should be handled. It's made me a much stronger advocate for the members I represent. Highly recommended.

I purchased this along with another union related book and found this one to be more applicable to private sector unions, not public sector unions, of which I am involved in. So this book was not as helpful as the other book I bought. But I recommend it to all of the union officers and stewards in the private sector.

This book should be the first thing any new union officer reads and as a long time union officer I read it at least once a year to refresh myself. As president of my local union I make sure all of our officers and stewards have their own copy to read and refer back to as they have need to.
