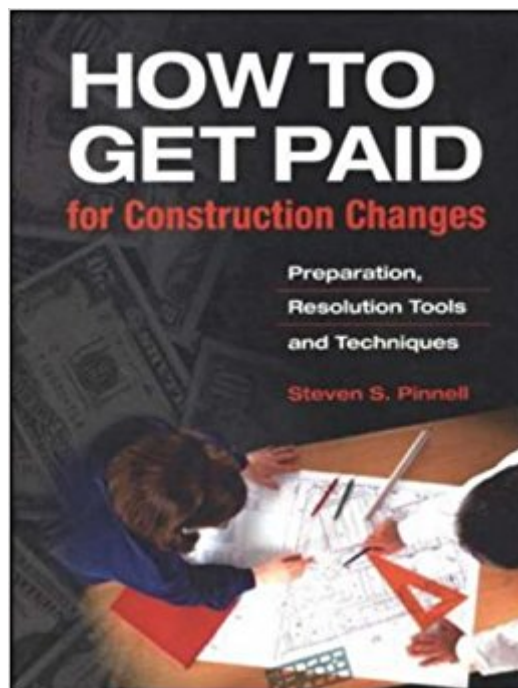

What I like about Pinnell's book is how it is written with the mind-set that "Partnering" and other cooperative processes need not be sacrificed for a contractor to get what he is entitled to.
