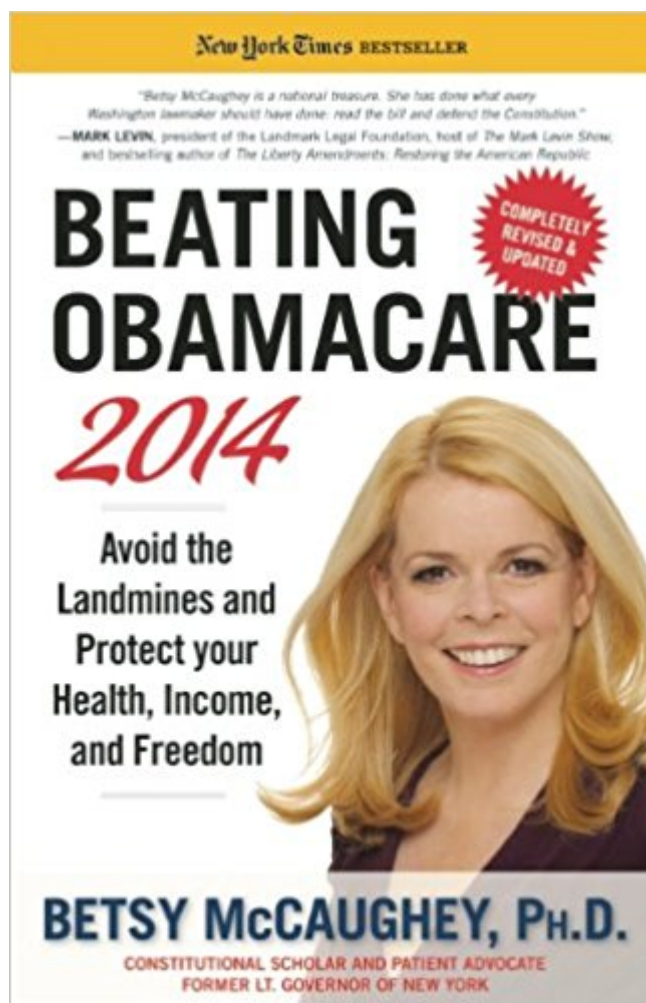

This book for me is misleading with its title. I read nothing that instructed me as an individual on how I can beat Obamacare. Contrary to the advertisement jargon, the book has NO info as to how one can "beat Obamacare". It advises, ""Politics got us into this mess, and we will have to use politics to get us out of it." Other great "personal-help" advice - "... first we must get rid of the special treatment for members of Congress...." and "We need a twenty-page bill in plain English..." There follows a self-promoting summary of the proposed twenty-page bill. The book does have 13 chapters and 162 pages explaining what's wrong with Obamacare, but most of those have already been discussed on tv, circulated in emails or posted on Facebook, etc. The book is of no value to explain how someone might "beat" Obamacare, and is, therefore, a waste of money for someone looking for actual help.

Just like the original book published in 2013 this title is misleading. The title gives the impression that you can somehow avoid Obamacare. You can't unless of course you die, that is an extreme place to go to "beat" Obamacare. This book should have been titled "Understanding Obamacare" because it is quite good at explaining the law in terms the average person can understand. However it gives you absolutely no way to beat or avoid the law.

borrowed this book, did not purchase it. while several arguments against Obamacare are presented, they are mainly unconvincing (to me) due to their over-simplification of real circumstances. the cover's promise, "avoiding the landmines and protect your health, income, freedom" goes largely unfulfilled as most of the pages are actually spent on justifying why Obamacare sucks (rather than explaining the implications of the ACA, its execution and what should be done now). ironically, such a one-sided approach makes McCaughey unequivocally guilty of the same fact-warping and cherry-picking strategies that she accuses the Obama administration of committing. but then again, what else to expect from a book titled, "beating Obamacare." my assumption is that those who have purchased this book already dislike Obamacare enough but why not add fuel to the fire? ah, bipartisan politics.
