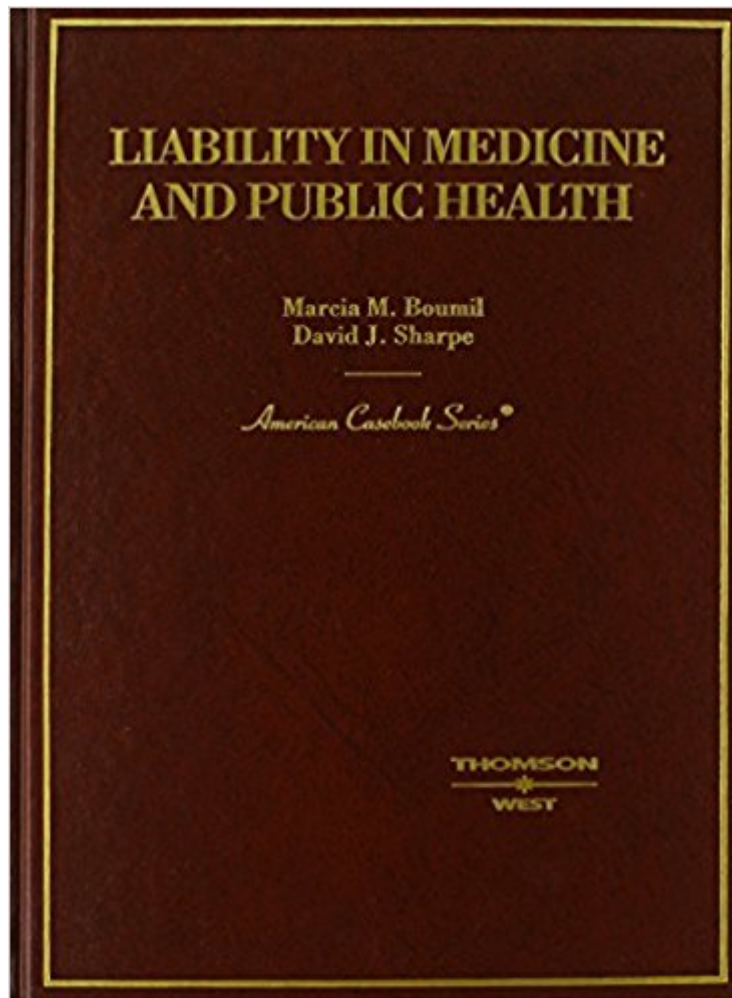

## Synopsis
