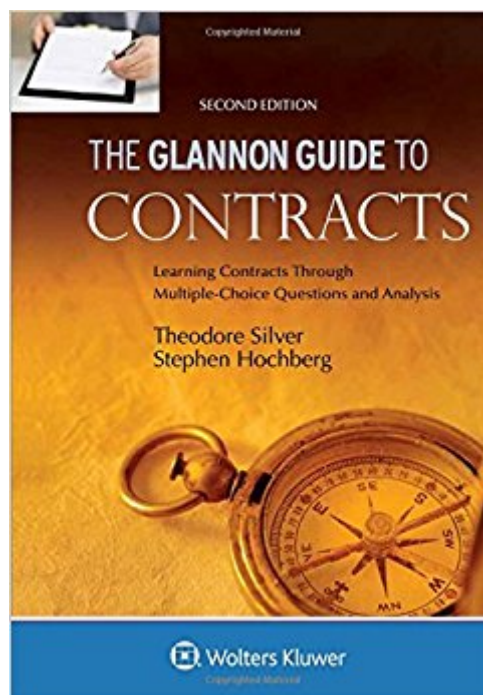

At first they are mere humorous distractions (\$5000 - \$2800 = \$1200) but as the end of the book nears the mistakes get so bad as to make it completely not understandable.
