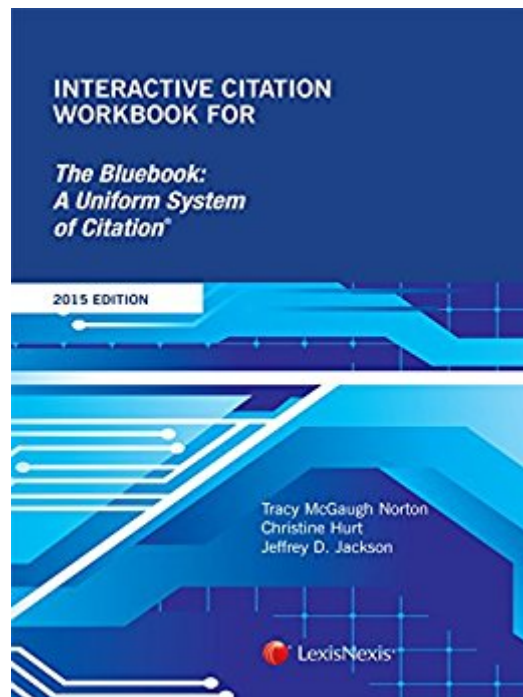

I've ever purchased. I loved how the Author states before continuing with the chapter you are about to read, turn to The Bluebook to read up on the Rules he's referencing in each chapter. Very easy to follow, I had no problems at all and it just 'level-up' my understanding of the Bluebook's Rules. Totally recommend it.

The Workbook itself deserves 5 stars. It does a fantastic job of breaking the Bluebook lessons down into easily digestible chunks. I highly recommend this resource for anyone wanting to improve on their cite checking or general knowledge of the Bluebook. However, I am only giving this purchase a 3-star rating because buying it here does not grant the purchaser access to LexisNexis' ICW page where the book's exercises can be graded. I feel like I understand the Bluebook much better now, but without the ability to grade the exercises it's difficult to accurately gauge one's skill level.

Be careful when ordering the Kindle edition of this book, it is not the same as the written version. I didn't notice the difference until it came to do the assignments, and they were completely different than what my professor had from the written format of the same book. Wonderful, now I have purchased the kindle format, and have to spend an additional 50 dollars for the written book. Ugh.

This book is a great supplement to the official blue book. They walk you through steps that are extremely confusing. If you take the time and do the problems in the workbook, actually using the Blue Book will be a breeze! The book was exactly what I ordered.
