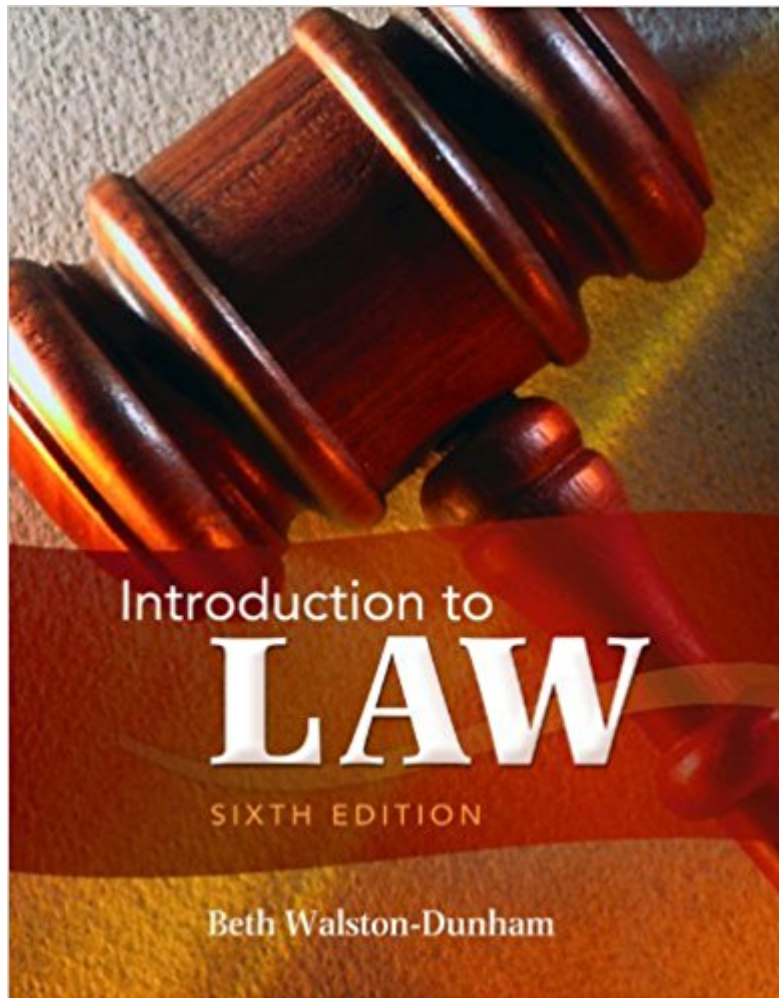

I ordered this book as a requirement for an introductory paralegal course and was at first a little apprehensive about the books thickness. I started out knowing absolutely nothing about the law, the government, or the internal workings of the legal system. This book teaches the beginnings of modern law and the influences of the executive, legislative, and judicial branches of government. The basics of many common areas of law are also covered such as contracts, probate, property, torts, criminal law, family law, and many more. This book teaches a great amount of useful

information in an easy to read and easy to understand format. Plenty of possible real life scenarios are used as examples as well as real cases to help you dive deeper into the subject you are trying to grasp. This is the first school textbook I've ever actually enjoyed reading from. Key terms are boldened for easier reference and studying. For anyone interested in learning about a variety of beginning law topics, it is definately an investment worth making.

I have purchased a number of law-related books from , but this book is by far the standout of the bunch. It systematically covers all of the major topics covered in the courses offered at every law school in the US comprehensively, even explaining the case briefing process. This new edition incorporates actual case law, allowing you to sample the work done at law school before actual signing your loan check and taking the plunge. Dunham clearly explains all of the basic terminology and principles underlying the first year of law school, providing the law student-to-be a firm foundation and a peace of mind before starting classes. I recommend this book without reservation to **ANYONE** interested in law school or interested in bulking up on their knowledge of the substance and form of law in the United States.

The book itself is great. But if you are Kindle users, be careful. The format of this book is different from normal Kindle. I don't know what calls, but it is like PDF. You just see many PDF pages on your Kindle. You can make highlights, but the screen reader is of course not workable. I get used to read books with Kindle, so I feel very uncomfortable to read this book with Kindle. I have to constantly adjust the size and layout of these PDF pages. It is better to read with a PC rather than Kindle. The printed version would be better.

Most of this textbook is filler - page after page of court opinions and sample statutes not directly relevant to the text. Another problem is spelling and grammar, as the book contains alarmingly frequent misspellings. While providing a generally decent overview of the areas of law, the book is at times diminished by an anti-American and social justice agenda. Chapters with less editorialization by the author, such as the chapter on Estates and Probate, are quite informative.
