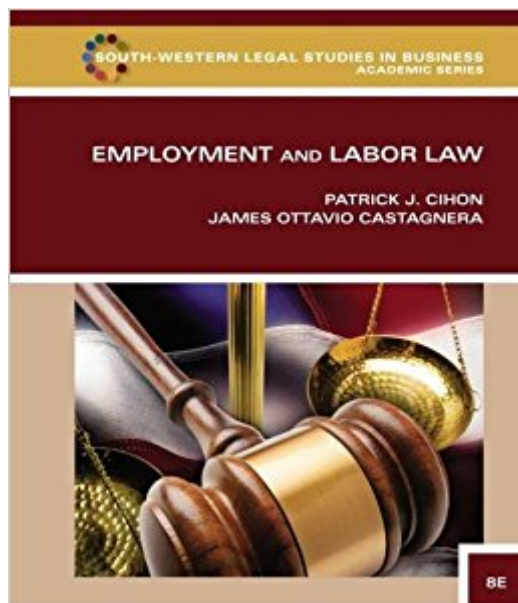

The only thing that bothered me was that a chapter summary of terms with corresponding page numbers was not given, which made it a little harder to look up specific terms. Summaries of cases are not clearly understood and the transition to tangential cases re: subject matter is poorly written.
