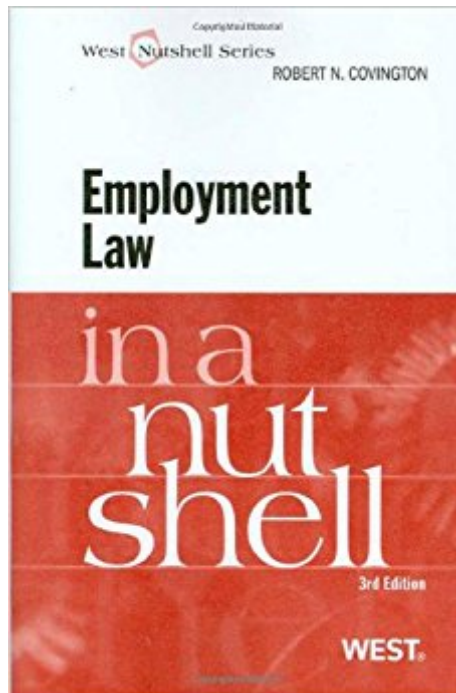

This book, like most of the other nutshells I've read, is not particularly helpful. The organization is confusing, and not enough attention is devoted to major topics, as the format is primarily just a recitation of cases. A study guide is supposed to provide a concise synopsis of the law, not merely throw a bunch of conflicting cases at the reader. Steven Emanuel has the market for law school study aides cornered, with the Examples & Explanations series a distant second. Unfortunately, this is the only major study guide that exists for employment law. Thanks to Rothstein's worthless and maddening casebook, learning employment law is neither interesting nor fun. This nutshell will provide some relief, but not much.

I find this book useful for law students and particularly for practitioners. It not only gives a birds eye view of employment law, but covers potential claims a lawyer may file. While its analysis and coverage is shallow (hence, the 4 stars), it's just enough to help a lawyer dive into deeper issues through Westlaw or Lexus Nexus. Overall, I recommend this book.

This is a good reference if you are taking the course as an elective. Provides a basic framework for the nuances of employment law and references significant cases.

This book is very good for those interested in employment law but who are not professionals in the field. I have recommended this book to my clients who are looking to improve their knowledge of employment law.

Very useful as an introduction to the overall topic. This book provides a necessarily broad overview of employment law, yet does a good job of delineating the sources of this law.
