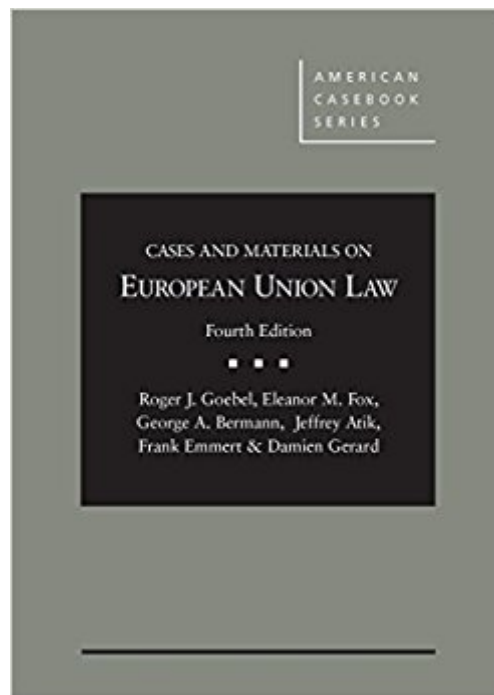

Part III comprehensively covers EU competition law and policy, of great concern to practitioners. The European Union's external relations and trade policy is the subject of Part IV, while Part V presents the impact of free movement of capital and EU banking regulation, and the Monetary Union. Finally, Part VI presents several key policy areas—the harmonization of employment law, anti-discrimination rules, environmental protection, and civil and commercial litigation rules.
