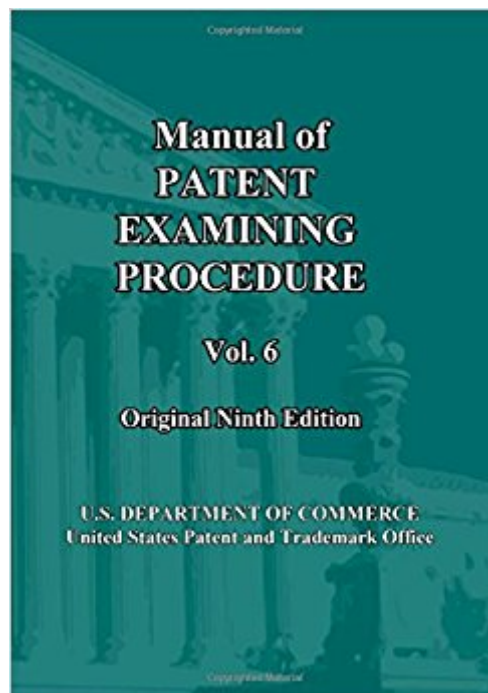

I'm glad they changed publishing houses. The previous issue (8th Ed, Rev 9, Patent Office Rules and Practice) was horrible. This time they didn't try to fit the whole set into one book, and it came out great. The pages are printed on heavy paper. The text is complete and well sized. I would prefer hardcover, but of course that would add cost. My only complaint is that these books are 30 cm tall. Most of my books are between 23 cm and 26 cm tall. I would like these to be about 25 cm tall even if that would mean making them thicker or increasing the number of volumes. You would think that for a seven volume set, they would have enough sense to include in the listing which chapters are in which books. Since they didn't bother with that, here it is: Vol 1: Chapters 100 - 600, plus the Forward and Introduction Vol 2: Chapters 700 - 900 Vol 3: Chapters 1000 - 1700 Vol 4: Chapters 1800 - 2100 Vol 5: Chapters 2200 - 2800 Vol 6: Appendices I, II, L and R Vol 7: Appendices T, AI and

P, plus the Index, Form Paragraphs and Instructions Of course the whole thing is available on-line, , for anyone who can do without the books. (To navigate there: start at uspto.gov; hover over "Patents" and click "More Tools and Links"; click "Manual of Patent Examining Procedure"; click "eMPEP")
