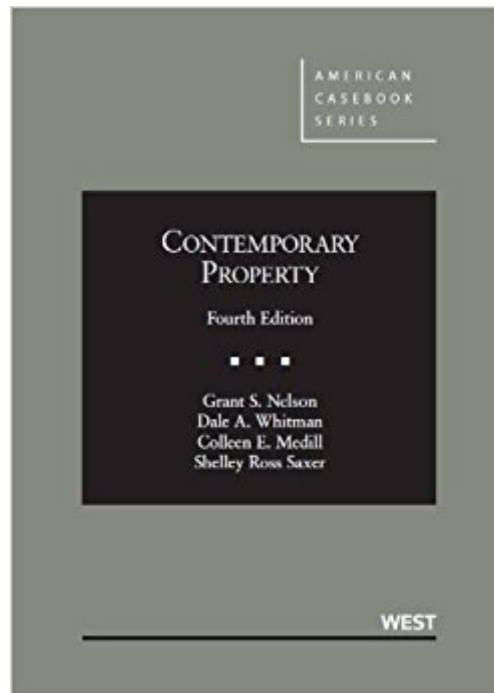

This textbook is not very well written and is full of typos. The way it's organized was difficult to read and follow -- most of the chapters start with a brief discussion of the topic followed by a fairly long and detailed majority opinion and some concurring and dissenting opinions. It's not until you get to the "Notes & Questions" section following each of the cases that the authors explain concepts and ideas that appeared in the opinions themselves. Thus, when you're reading the case, it's difficult to understand the reasoning since the text hasn't yet given you the tools or framework for doing so.
