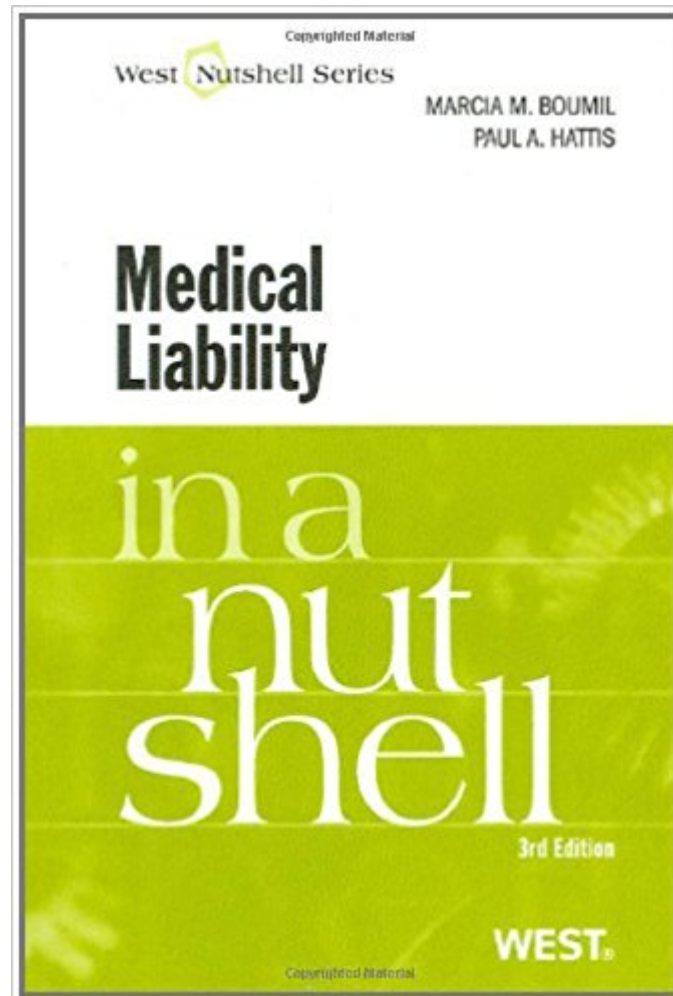

Maybe there's such a wide variety of approaches among jurisdictions that it's difficult to achieve depth and breadth. If you're just looking for some basic knowledge as a lay person, go for it. If you're a law student, there's probably something better out there that's more helpful for exam purposes.
