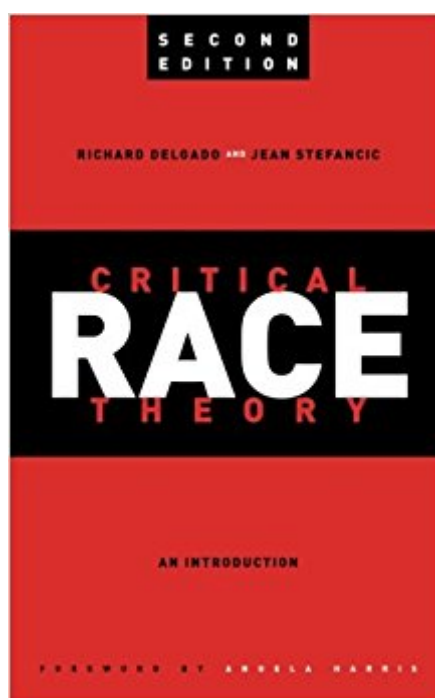

Critical Race Theory: An Introduction, as the title suggests, is intended to be a primer. Critical Race Theory (CRT), "...considers many of the same issues that conventional civil rights and ethnic studies discourses take up, but places them in a broader perspective that includes economics, history, context, group- and self-interest, and even feelings and the unconscious." (p.3). Authors Delgado and Stefancic provide the basic foundation behind the the theory as well as explaining some of the principles such as: interest convergence, structural determinism, and [legal] storytelling, to name a few. Also, in the interest of fair-mindedness, one of the later chapters is dedicated to

those with opposing viewpoints and expounds on what that opposition entails. At the conclusion of each chapter, 'classroom exercises', 'questions and comments', and 'suggested readings' are provided for further clarity and analysis. I personally thought the exercises and questions were constructive and thought-provoking; a noble attempt to provide practical application of theory via real-world scenarios.

I think I was expecting a bit more from this book but I had to keep reminding myself that it is an introductory text. I did find issue with most of the questions at the end of the chapters. Aren't lawyers supposed to avoid leading questions? Overall, this is a good starter text if you've no familiarity with CRT. But if you've done any race work at all, it is a bit elementary for you. However, it may fill in some gaps you didn't know were in your knowledge.

Richard Delgado is a law professor at Seattle University and has written numerous books on race and law relations. Jean Stefancic is a professor of research law at Seattle University and focuses research on civil rights, law reform, and social change. This book lays a clear and concise foundation defining critical race theory (CRT) in this 17 part anthology. This book is acclaimed as the indispensable guide for all things that need to be known about critical race theory. CRT started in the 1970s after the realization that the Civil Rights movement had stalled and many legal judgments were beginning to be overruled. The ground breaking work of Derrick Bell and Alan Freeman has propelled CRT into an indispensable theory heavily used to explain the underlying issues of race and class in the United States. While this book has chapters that touch on an array of topics involved with critical race theory, one of the most interesting sections is the section on storytelling, counter storytelling, and naming one's own reality. There are several chapters that deal with race, sex, class and how they intersect with each other. Critical race feminism, criticism and self-analysis of race and class as well as cultural nationalism and separatism also receive exhaustive coverage.
