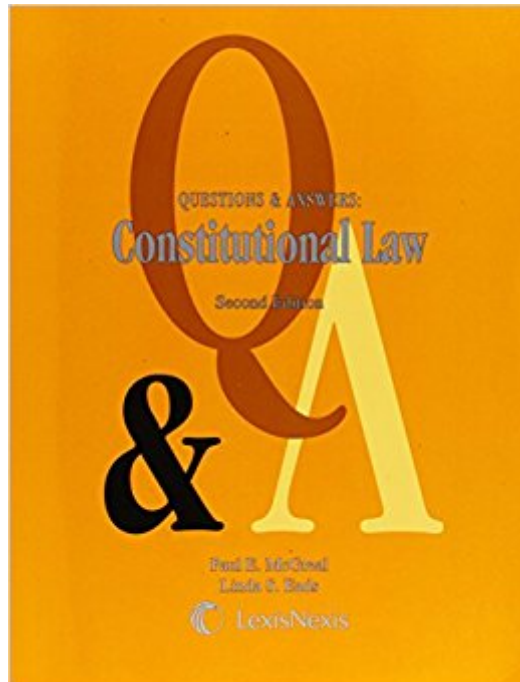

My low review is entirely unrelated to contentâthe answers and explanations are superb, and are extremely helpful, HOWEVER...The Kindle edition, unlike other Q&As for Kindle that I've used in the past, does NOT have an internal hyperlink to the answer for each question. When each answer is so illuminating and helpful, I prefer to immediately read the answer and explanation in the latter half of the book. The fact that whoever created the kindle edition failed to put a link from the question to its answer made my studying extremely tedious and very annoying. If you're going to put out a Kindle edition of something like this, it NEEDS to have links to the answer and explanation.

What can I say? If you're a law student, you know why study aids are important. My

recommendation is to get the kindle version of this book because it's been so convenient for me to have this and my Chemerinsky treatise accessible at any moment on my Kindle Fire.

Prefer Siegels or Friedman, but if you want to maximize the number of questions you do, get Q&A, too. Fact patterns are a bit longer than you are likely to see.
