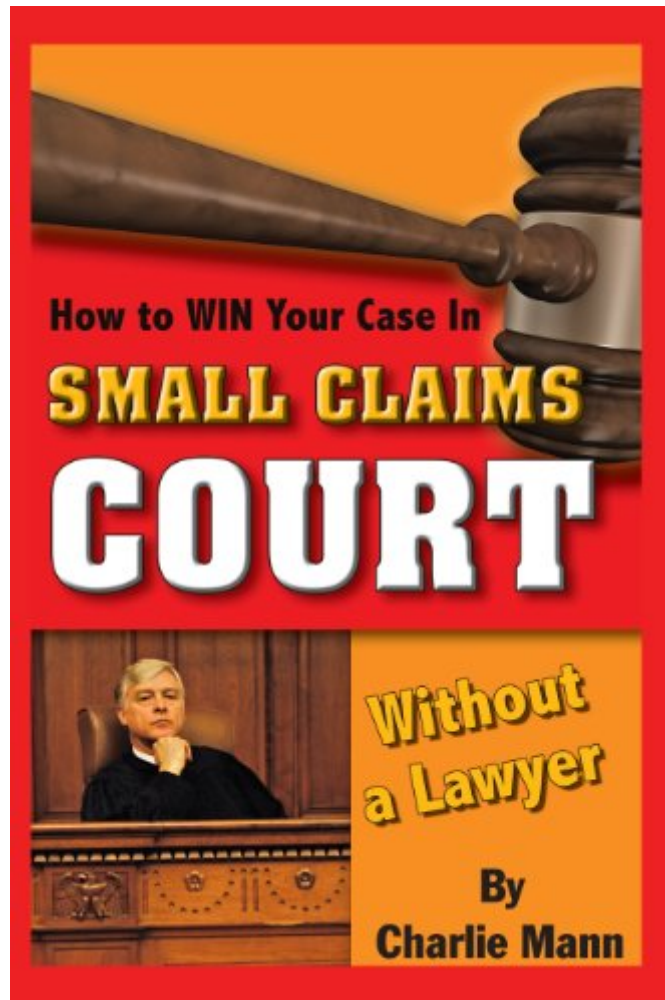

This is the perfect step-by-step book on what to do if you think you have a case that you want to take to small claims court. It starts with basic definitions of what a small claims court is, what types of cases are usually tried there and advice on how to know if you have a sound case or not. It is broken into chapters, each addressing a key issue involved with going to small claims court. The first few chapters include what you will need to do to prepare for small claims court. There are many good examples of "demand letters" which is the first step in beginning the process of going to small claims court. The author also includes many good resources that you can use to help determine if you actually need to go to small claims court. Subsequent chapters deal with many special issues, such as what types of things can go wrong in court, such as countersuits and counterclaims. The

author examines an exhaustive list of the types of cases that can be brought to small claims court, very helpful if you aren't sure if you even have a case or not. The author goes through how to get organized for court, including how to budget your time and what kind of paperwork you will need to have prepared. Next topics such as: problems that arise before your court date, preparing for the actual day in court, how to select an expert witness, and what to do if you lose your case are discussed. The appendices are extremely helpful. There is a glossary of terms which covers pretty much any word that you may need to know in reference to small claims court. The appendices also include a state by state listing of the most important information for each state's small claims court.
