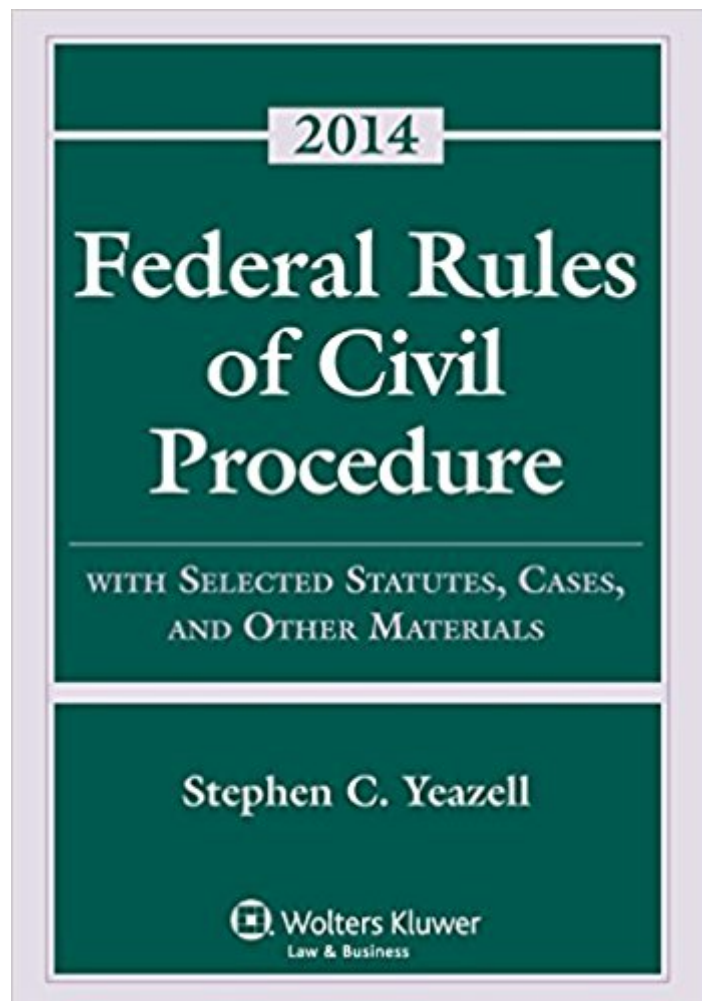

The pages are thin, so you need to be careful about highlighters bleeding through. Other than that, it is well laid out, has a few good cases in the back, and generally does the job of being an effective reference tool.

I am using this book in my first year Civil Procedures law class and find it very user friendly. It is laid out in an easy to find order and the outlining of this book is very useful. It is not nearly as heavy as any of my other law books, which is a huge plus, and I am definitely relying heavily on it to help me understand rules and concepts in the law. Buy this book!
