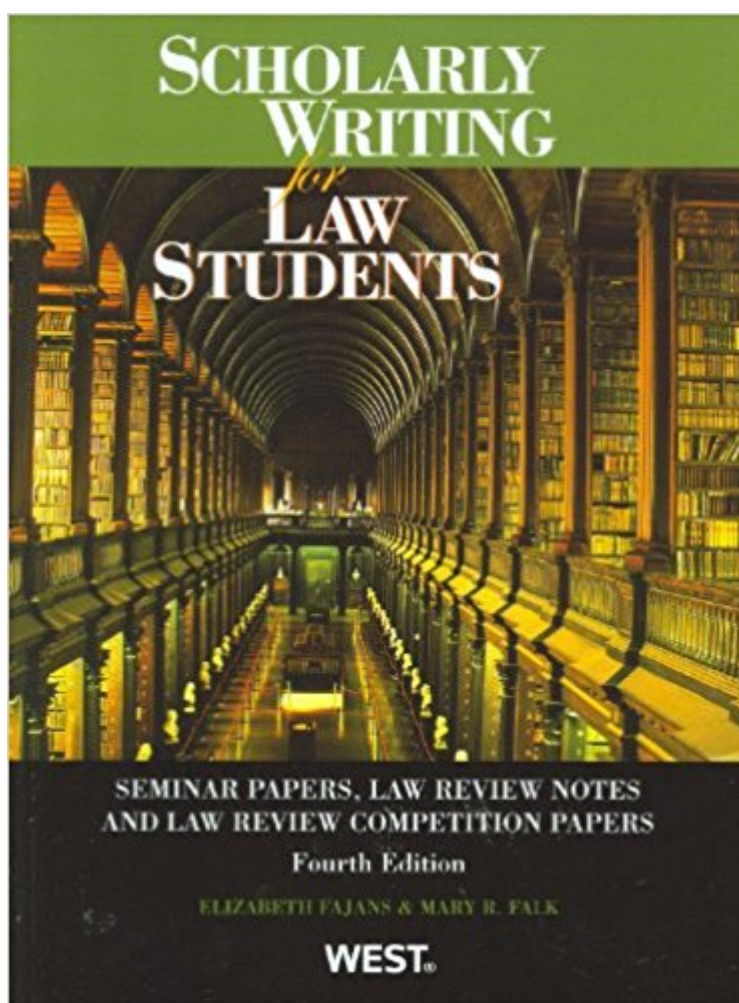

Synopsis
