Without appology I recommend that EVERYONE SHOULD READ THIS BOOK. You should order it along with the book "Silence is Power: A Step-by-Step Guide to Handling Police Interrogations and

Protecting Your Freedom" by adebayo Ogunmenon, BA, JD. If you want to know what police do to get information out of a suspect this book will certainly give you an idea. The first mistake that most people make when questioned by the police is to assume they are idiots. Police are not stupid when they sit you down and say "We just want to know what happened". Your best bet is to be prepared, to know how police think and know how best to respond. HOW TO BEAT A POLICE INTERROGATION will give you a HUGE head start. My personal interest in this topic comes from knowing how people are manipulated into doing things that don't serve them. The police certainly know how to trick their suspects into revealing information. The police even know how to make someone confess to things they did not do! Short, but full of interesting advice. This is an interesting view from the police side of the interview table. In general this book can be summed up as "give your name and address, and say nothing else".

I'm a strictly legal kind of person, but one never knows when the beady eyes of the local coppers will fall upon one. Valuable advice regarding interview/interrogation. Watching a few episodes of law & order will also help, but keep in mind that POLICE are not able to offer a deal, as they seem to do quite often on L&O, only the prosecutor can. Best advice, don't draw police attention to yourself and if you do, keep the mouth shut.

Great advice and a very entertaining read when you understand what the author is saying? Unfortunately, there are a great many cases where you will not simply be unsure what he is saying...no, you will throw your hands up in the air and give up trying. It appears to me that the book was probably dictated by the author and then handed over to a computer for voice-to-print translation, but some of the dictation was too much for the program to handle and so the translation came out garbled. The problem is that nobody has bothered to check the computer's work and correct its errors. Either that, or the author just doesn't care, which is insulting if true and which does disturb the lighthearted, tongue in cheek spirit of the book with just a hint of ugliness. Nevertheless, I recommend the book. The advice that isn't advice because he's not a lawyer wink wink nudge nudge is solid, and could save you from a world of hurt if you ever find yourself the subject of an investigation...even if you are completely innocent.

This book supposedly was written by a lawyer, but it seems more like it was written by an ex-con. I had assumed that it was aimed at people unjustly targeted by the police, but it seems to be aimed at helping actual criminals get away with their crimes. That said, it does present information which might be vital to the unjustly accused. One thing which shocked me, but I have confirmed from other sources, is that the police in America are permitted to lie when questioning people. I understand that many other countries don't permit that. So, if they tell you they know you did it, it doesn't mean that you did and have forgotten about it. Also, the book warns that an officer who seems sympathetic is probably trying to trick you into saying something that will hang you. The writer warns that your best bet is to exercise your right to remain silent, and to insist on having a lawyer present if you are questioned.

First I have to say that this book is poorly written and poorly proofread. It feels like it was written by a high-school dropout who tried to appear smarter than he is by avoiding contractions and tried to appear funnier than he is by over-using the phrase, "Graybar Hotel." That being said, I don't think anyone will buy this book expecting flowing prose and deep insights (you'll notice I still gave it a 5-star review). Its purpose to educate the reader on the methods used by the police to extract a confession and it excels at that. It explains how to keep from getting interrogated in the first place, when to keep your mouth shut, when to "lawyer up" and most importantly, how to keep yourself from cracking and confessing to a crime you may or may not have committed. I was most surprised at the amount of lying that can go into an interrogation. If you are the type of person who frequently finds themselves on the wrong side of the law, this is an invaluable resource. If, like most of us, you will probably never be a murder suspect, this is still an entertaining read and is well worth a couple of bucks. It reminds me of *How to Drive a Tank and Other Everyday Tips for the Modern Gentleman* in that it will probably never be useful to me, but it feels good to be prepared.

I loved this book! Even with all of the grammatical errors, I was motivated to read on. The author gives so much good information. The anecdotes are amusing while they flesh out what the author is sharing. I was not reading this to find out how to win in a confrontation with the police. Instead, I read it to gain a better understanding of how police think and operate. The information presented makes me wonder why police don't bother interrogating men suspected of rape...if they are so good at extracting confessions from guilty people. I think it is because they do not care about rape:(
