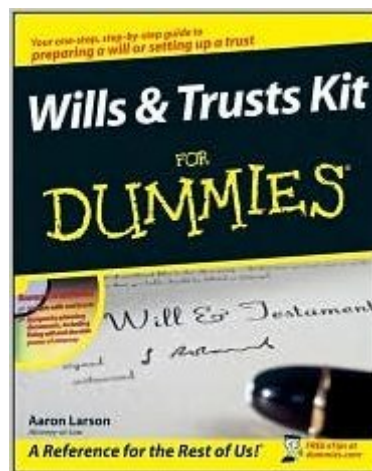

I am a Civil Notary in Louisiana. In Louisiana, notaries have the legal power (and legal responsibility) to prepare all sorts of documents and perform all sorts of official personal and authentic acts. In Louisiana, Notaries can basically perform all legal document preparation and notarization, including, but not limited to: deeds, Power of Attorney, small successions, Custody By Mandate, Wills, Trusts, LLC and Corporate documents required for federal and state governmental bodies, etc.), with the exception of preparing divorce papers (most of my clients use legal zoom for that service) and representing clients in court. These acts are practicing law (as defined in Louisiana). Louisiana notaries CAN notarize divorce papers and, as stated above, prepare legal documents, in essence being paralegals. This book is full of practical knowledge, examples, and provides the basis of understanding of Wills and Trusts. This book should be part of the Legal Library that any Notary, Louisiana or otherwise, has in their possession. Rating for completeness 1-10, I'd give it a 10+ !!!!!!!
