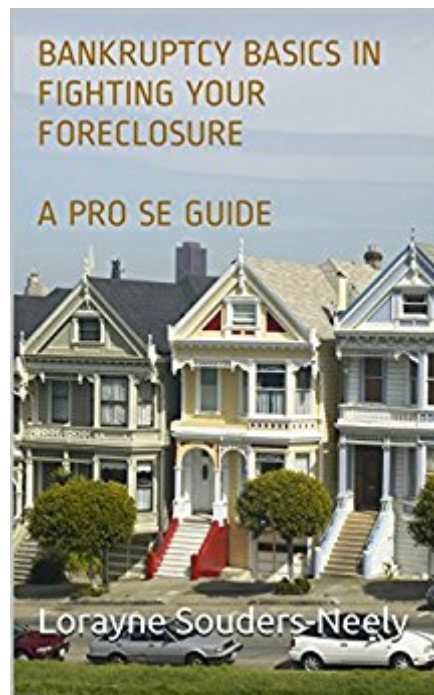

The Nosek case also explains how the servicer failed to correctly credit the chapter 13 payments to the debtor's account. Thompson v Wells Fargo - you will learn that these Pro se litigants were successful in stating that Wells Fargo is not the holder of the note and as a result the Judge requested that Wells Fargo refund to the debtors all of their Chapter 13 payments.
