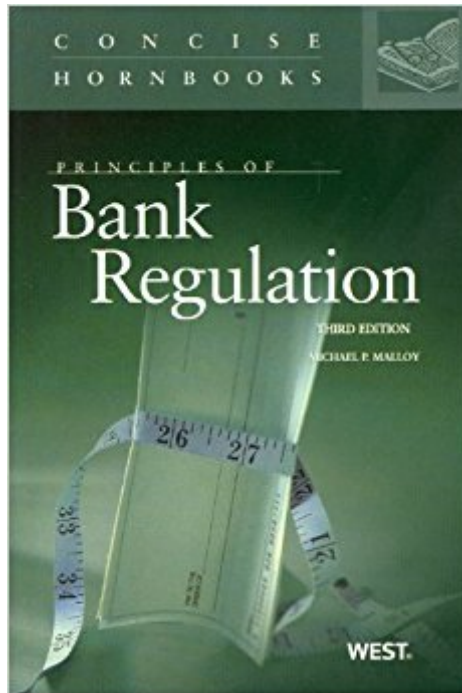

It's difficult to find a banking hornbook that doesn't pre-date the 2008 financial crisis. This book, having been written in 2011, is definitely relevant. It was published before the OTS was shut down, though, so I had to keep remembering what functions the FDIC was going to take over, etc. But for someone with no knowledge of banking regulation or the financial system, this book was a God-send. It had an excellent discussion of Basels I-III, and walked you through the entire timeline, from getting your charter to going into receivership. Malloy consistently references the applicable statute sections, so it's a good idea to keep your statute book handy in order to cross reference and annotate. I am 100% glad that I purchased this, and would absolutely do it again.
