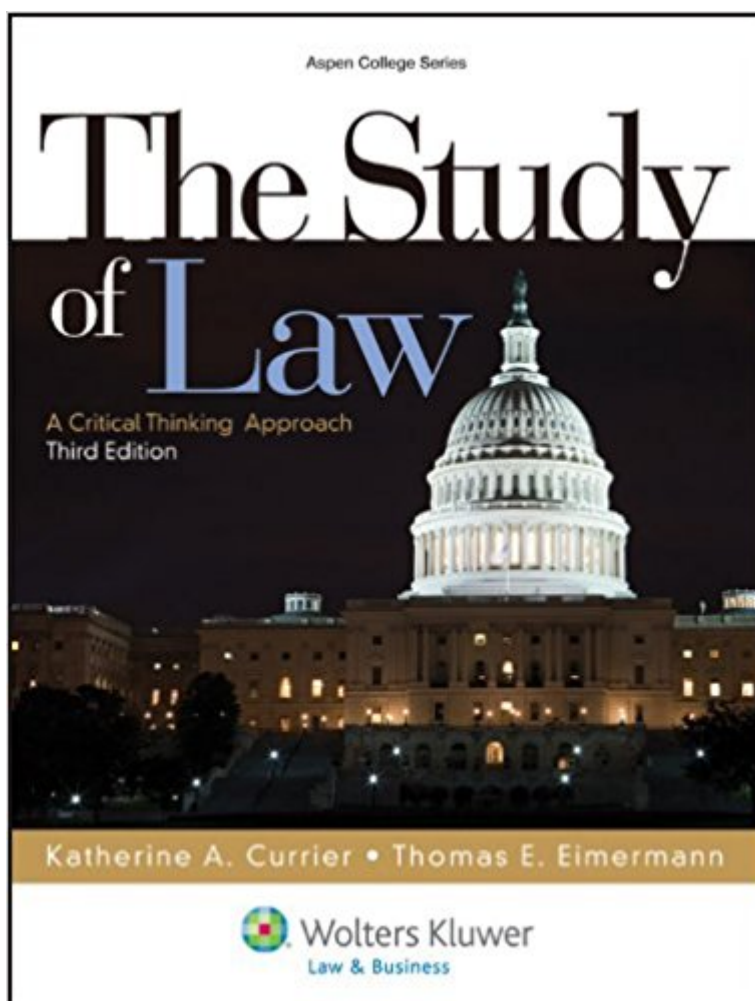

The text is divided into two parts, reflecting the order of topics addressed in a typical course. The first part, Introduction to the Legal System, presents the sources and classification of law, the structure of the court system, and an overview of litigation. The second part, Basic Legal Concepts, covers the fundamental analysis and interpretation of the law as well as substantive law. The chapters on substantive law use carefully edited cases to teach students how to read and analyze the law. The Study of Law teaches students the basic skills necessary to understand statutes and court cases, and effective pedagogy reinforces the accessible and well-organized text. Appendices address the U.S. Constitution, Fundamentals of Good Writing, and NetNotes. The Third Edition features updated cases and incorporates new developments in the law. Legal reasoning exercises similarly reflect new cases, and Web exercises accompany this revised edition. Generally speaking, it does a very good job--I almost wish I had had such a book when I first started law many, many years ago. It does a good job of giving the big picture. Good set-off of definitions. My only critique is that this book is written at a pretty sophisticated level. Great if you are an upperclassman but some community college students may find the book challenging, especially if they are not adept at understanding intangible concepts.
