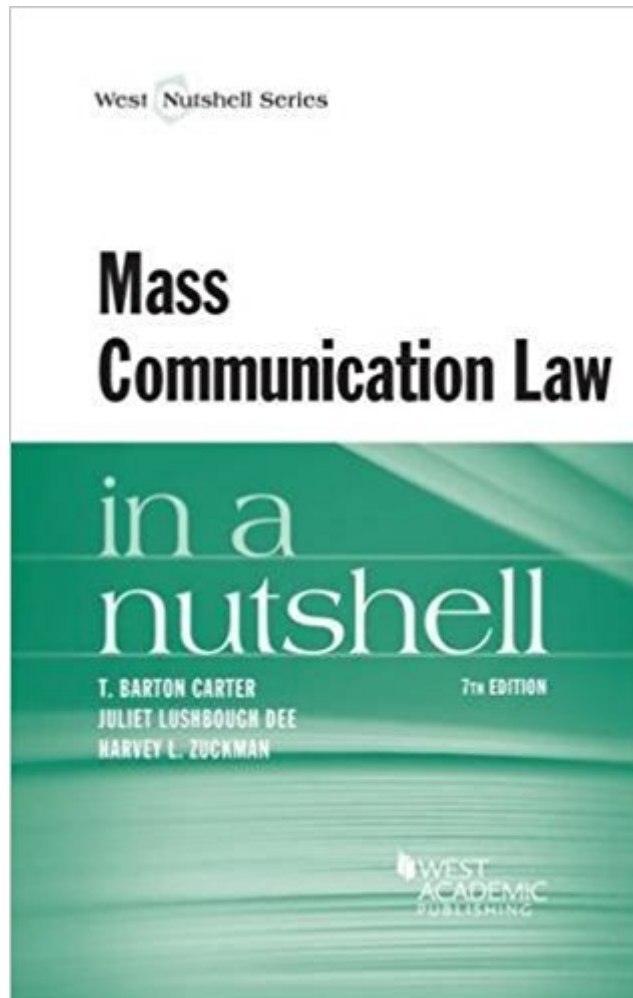

## Synopsis
