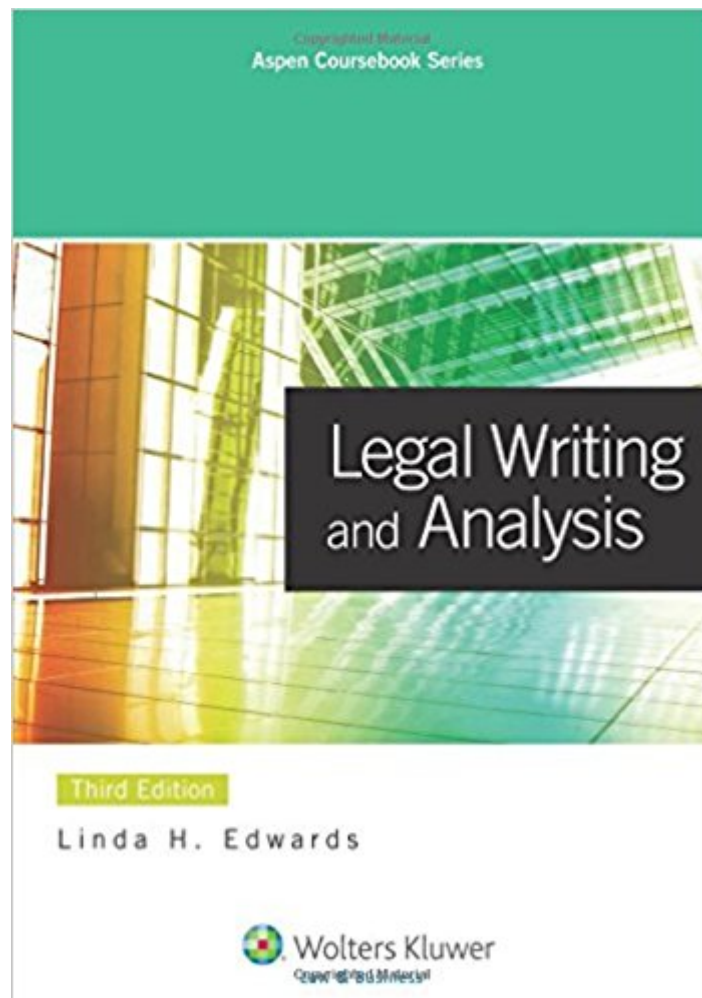

I will start by saying what I think is right about this book. It is packed with helpful information. The writer can deliver helpful insights. The book is decently priced. Here are my complaints about this book. The book is poorly organized. The writer uses words that she doesn't understand the actual meaning of. For example, the word "paradigm" is so misused I find it offensive. The writer uses words like, generally, sometimes, probably, maybe, and possibly in such a manner that it is jolting and choppy, and leaves the reader wondering about the confidence you could have in the information. Chapter 7-12 could benefit from rewriting, and organizing into the actual order that a person would encounter in constructing the memo from the material. As it is not organized in this manner, the reader is forced to flip back and forth, and hunt haphazardly for connecting ideas and materials. Also, the way the writer repeats the phrases repeatedly makes the information harder to digest, and easier to get confused. Entire sections of the book could be truncated and the reader would benefit drastically. All this being said, the topic subject was probably not easy to write about, and considerable effort was probably put into the book. Generally, you could commend the author on these grounds. See how jilting that type of writing is.)
