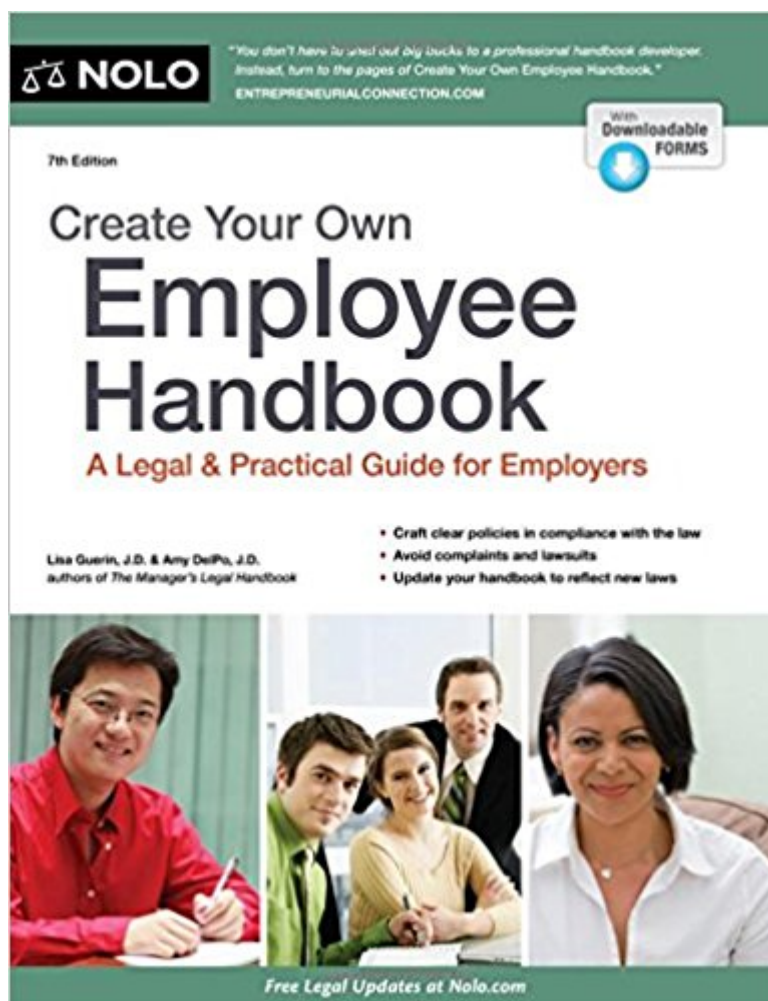

I initially saw this book at our local public library. I looked at it skeptically. I have written many employee handbooks and know first hand that the process is much more involved than many think. That said, this is a really good resource - IF you know what you are doing. For an experienced HR person, very helpful, some good explanations and language options. If you have never written a handbook before and/or don't have an HR background: proceed with caution.

Let me just begin by saying that the content of this book was SO apparently solid that, even though it arrived bent and warped from water damage (not as advertised), I cancelled the return I had commenced and have held on to it since, in all its deformed glory. This book saved me hundreds in legal fees. It (1) provides the foundation for any company's handbook, whether you're starting from scratch or reviewing and supplementing an existing one, (2) provides additional or alternative language to consider depending on your situation, (3) provides a checklist on the outer pages so that you can keep track of sections you want to incorporate into your new/existing handbook, (4) is organized how you would want your handbook to be organized, and (5) is so easy to understand and implement that anyone could make their own handbook. All I wish is that the book also came with the sample language on a disc so that I could save hours of time in adopting and revising some of the language. This book is a must-have for those wanting to create a handbook on their own.

This book gives specifics needed in making your handbook street legal while allowing you to mold it to fit your situation. Big help, big aid in writing a comprehensive handbook that keeps the vulture lawyers at the gate.
