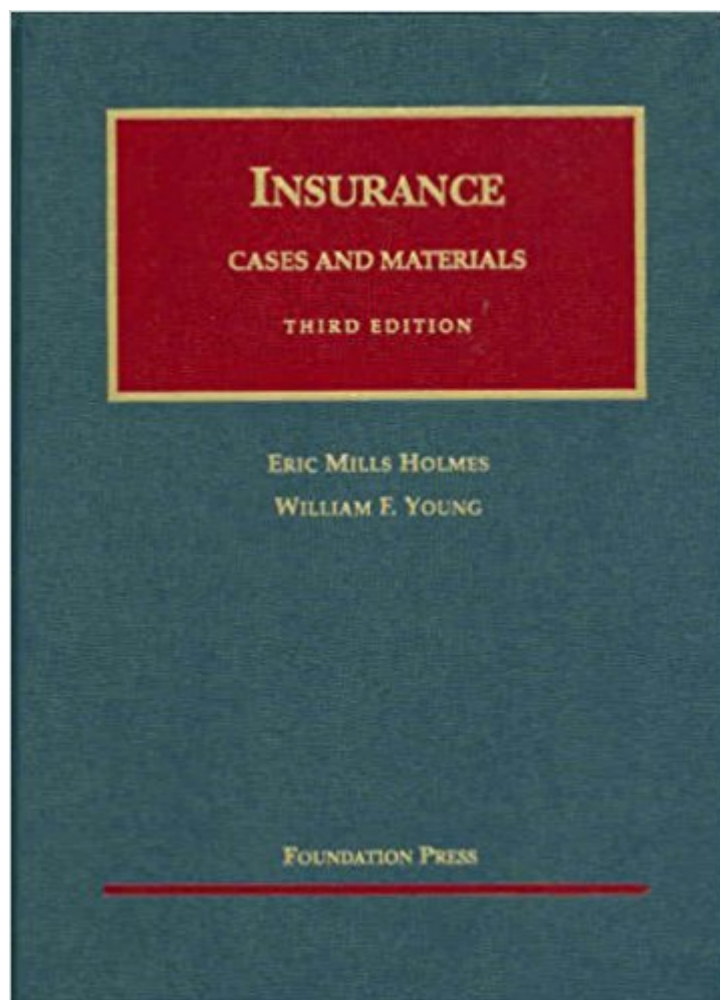

It lends itself to a shorter one, and in either case, by variety, to selective emphasis. An instructor might choose to emphasize the popular lines of insurance, policy terms in general use, and advocacy in insurance disputes.
