Here is an edited copy of the email that I sent to the publisher on August 26, 2012 (one month ago), for which they responded that they would look into the issue:-----I recently purchased the CrunchTime series for Torts, CivPro, Contracts, and Property (all of my first year courses) from for Kindle. I'm writing to you, the publisher, because I don't think has any control over how the material is displayed in Kindle, although this may be incorrect. These books are great, and the reading material is excellent. HOWEVER, the flowcharts and general display of the various information on Kindle is terrible. As an example, I have [uploaded a picture to in the Civil Procedure review], which displays Figure 3-1. Unfortunately, I cannot figure out how to zoom in on any of the figures, so their text size is automatically left for Kindle to decide how big it should be, and in many cases (such as in the attached image) the figures are ILLEGIBLE. Do you know if there is there any way to zoom in on the images, so that they are clear? An example would be a typical PDF document, where the user can manipulate the page orientation (some of the figures are sideways, which is not helpful when viewing on a PC), and zoom in on certain areas of the page, while retaining clarity of text. I wanted to write to you before I unfairly write an unfavorable review on for the product, stating my concerns identified above. Some of the best information that is unique to the CrunchTime series is illegible on Kindle.
