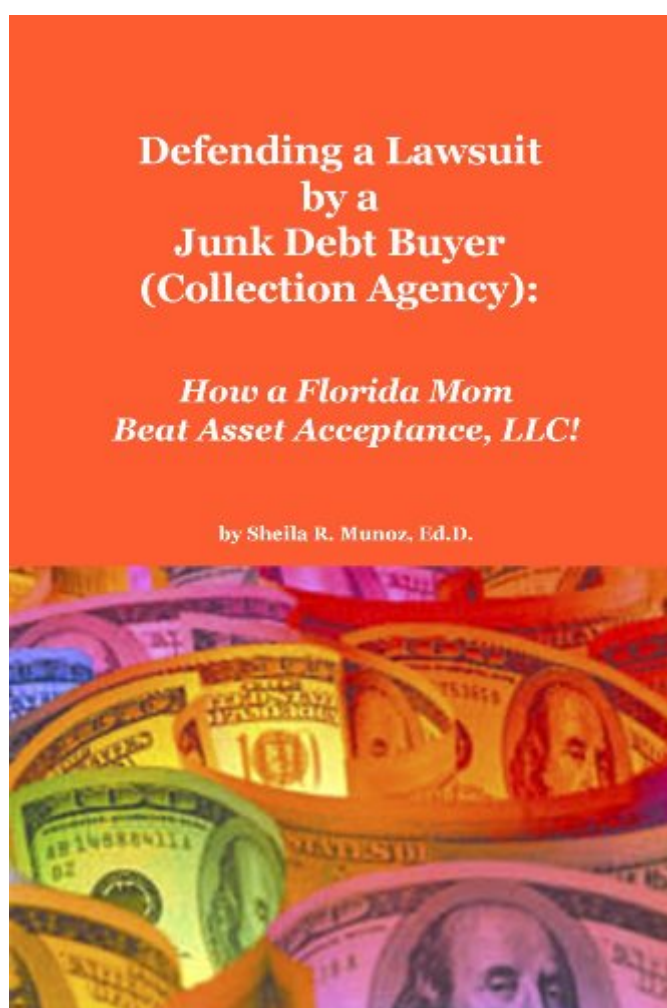

Great place to start if you're facing a 'junk debt buyer' lawsuit. Not nearly all inclusive, but if you wanted that, I suppose you'd go to law school. I found it very helpful as a framework from which I could search for more information- much of it online. It also made it easier to have intelligent conversations with lawyers about my predicament. When I was initially served, I quickly discovered there were not a lot of lawyers who were willing to deal with debtors, especially on debts of a

relatively small amount. This book, paired with a good online search engine, gave me the basics on moving thru the wonderful world of defending myself in civil court (on several occasions). A few things I learned: 1. Junk debt buying/selling is a huge industry, and there are numerous opinions/commentaries out there on the fundamental fraudulent nature of this business. But, there seems to be no real action against it, because all the 'money' is on the creditor side. 2. JDB (junk debt buyer) claims at this level seem to be completely dependent on the judge. Hope you get a 'debtor-friendly' judge, otherwise all the arguments Ms. Munoz covers in the book are right out the window. 3. Being sued by an 'assignee' (i.e. JDB), is completely different than getting sued by the primary creditor (i.e. issuing bank). If it's the primary suing you, 'beating it' is not at all likely. 4. This legal arena is madness. Nothing makes sense. It's not "People's Court" or even small claims court between two people pro se, where a simple question has a simple answer.
