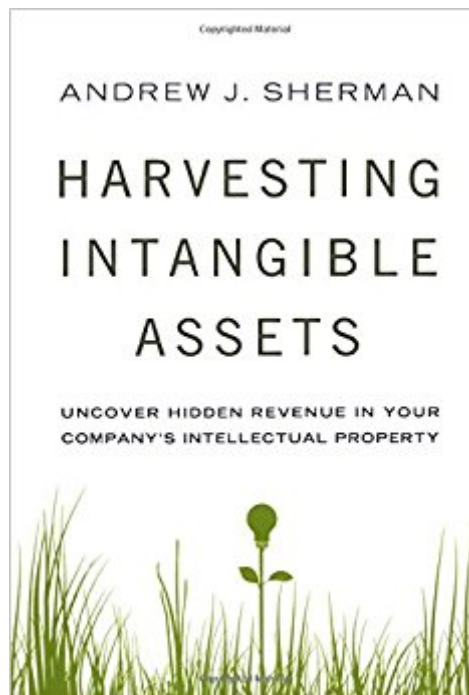

Along with being the father of modern philosophy, and of modern geometry, Descartes might be credited as the father of intellectual property management ("I think, therefore, I am."). He was certainly one of the key figures in 17th Century rationalism. If Descartes were around today, he might use Andrew Sherman's "Harvesting Intangible Assets" as a reference book. In this one book, Sherman has combined an excellent set of best practices, along with case studies, and a resource list. When the history of post-Internet capitalism is written, how well startups and well-established companies have developed and harvested their IP will be a critical chapter. Sherman is probably working on it now.

In this innovation-driven economy, this book is a must-read! Andrew takes a pretty complex topic and, presenting it with useful examples (like 3M's Seven Pillars of Intrapreneurship on page 65) and

pragmatic insight (12 Ways to Avoid Pilot Project Crashes on page 135), makes it understandable without "dumbing it down". He shows in clear terms how to leverage intellectual property as a competitive weapon, whether you created the IP or someone else did. Although he focuses a great deal on large companies, current and aspiring entrepreneurs could greatly benefit from the insights, processes, and outlines provided in this book.

At a time when corporate leaders are struggling to drive shareholder value, lawyer and strategist Andrew J. Sherman has delivered a road map for harvesting the company's intangibles. This book draws on core principles of our agrarian roots to offer lessons applicable to both entrepreneurs and leaders of Fortune 500 companies alike. The book is chock filled with best practices, case studies and insights assured to produce a bountiful harvest!
