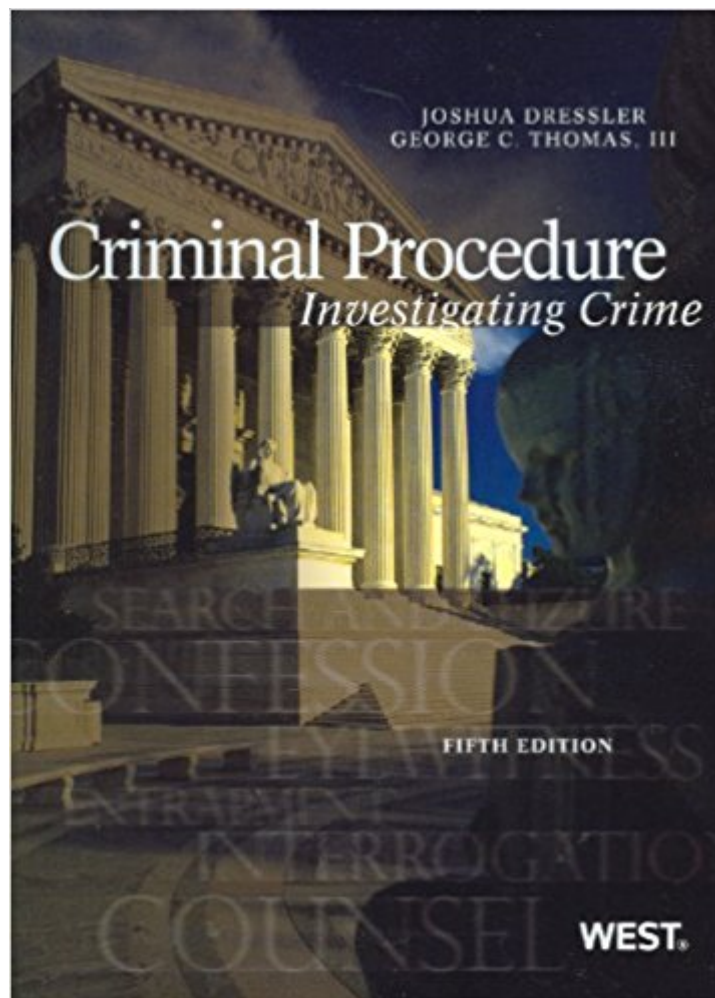

A great book for students and practitioners who want a solid understanding of the great Supreme Court cases that have molded key doctrines of criminal adjudication. From the earliest cases involving trials by jury and the exclusion rule, to the latest cases in evolving Miranda and 4th Amendment search limitations, Dressler does an excellent job of selecting the cases and following up each case with questions and comments.
