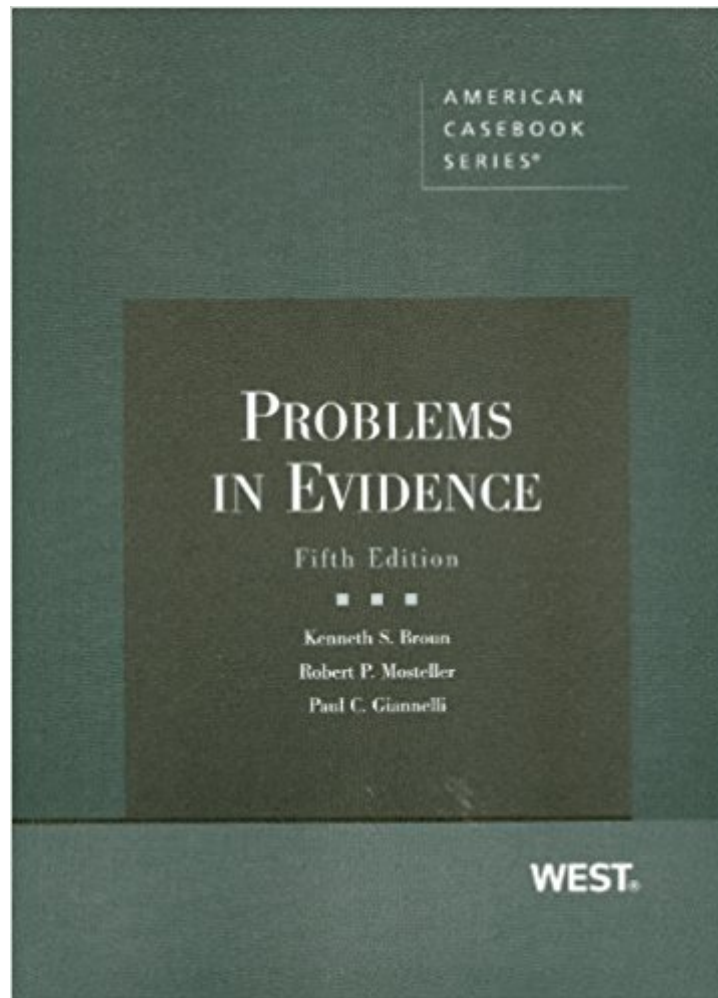

Forty new problems have been added to this edition. Many concern the range of issues created by the Supreme Court's new approach to confrontation in *Crawford v. Washington*. A number have been added for expert testimony and revisions have been made regarding DNA evidence. Some examine the challenges presented by new technology when evidence comes from cell phones and computer hard drives. A new problem also raises issues that the new federal rule concerning "inadvertent disclosure" of privileged attorney-client material can help resolve. Long-time users of this Problem Book will find some of the questions in what we believe are more logical locations.
