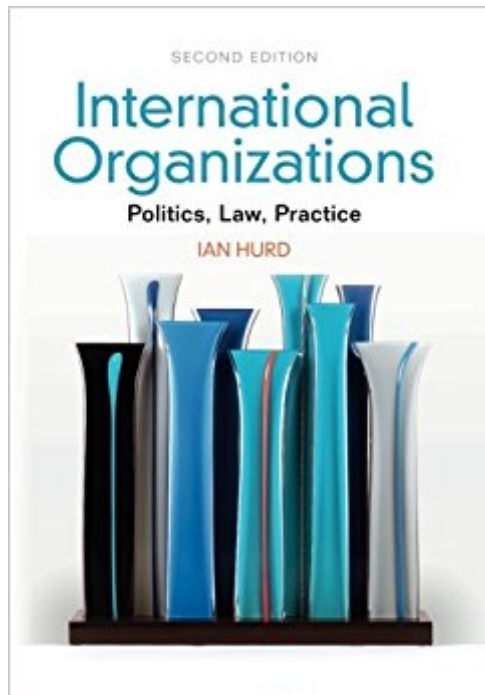

This type of writing, which is not simplified, makes it hard to digest the concepts from one sentence to the next. I have had to go back and re-read paragraphs or pages just to get the gist of the concepts since so much information is packed into it. Great intro material wise, but not the best book I have ever read as an intro text to a non-intro class. The case studies make things a bit clearer, but still, I recommend against buying unless it is an assigned read.
