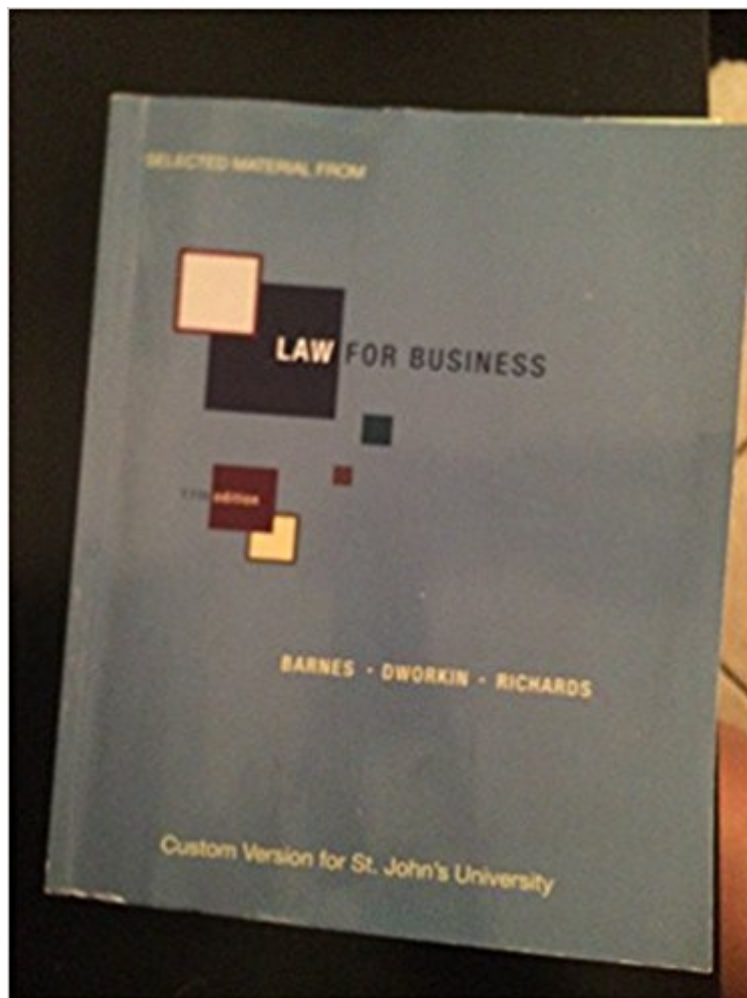

There are some words that are in bold in the text, but they are not included in the glossary. However, overall I think it does a really good job of making this information as clear and easy to understand as possible and I really like the example cases. The questions at the end of the chapters are also very useful and can help review the main points of the chapter.
