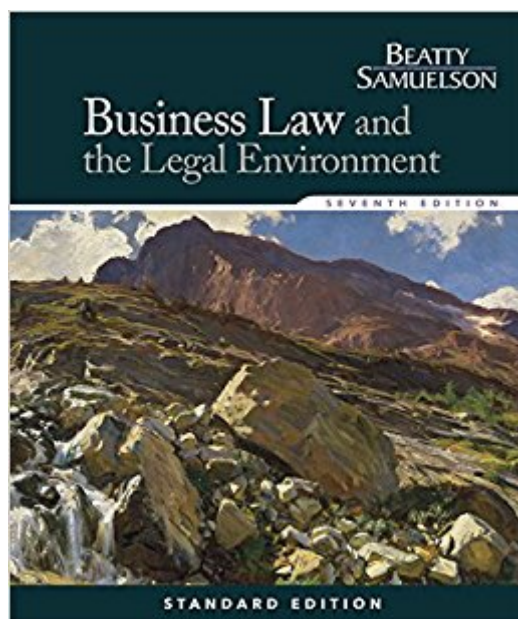

down the concepts so they are easy to understand. Even if you hate law, if you put forth the effort to learn this, you should have no trouble at all learning and understanding the concepts. Out of all the books that I have for this term, this one is actually my favorite... it even has some chapters I'm not supposed to use for this class, jumping around according to my syllabus, but have nonetheless used for other classes because they contain the same info, in better format, than the other book for a different class (I know, you're not supposed to do that, but if it has the same key points as the chapter outline in the other book, what's the difference if I can pass the test at the end and retain more info from a more readable book?) :D This is a very useful book, the glossary I would give a grade of "C"... terms you expect to be there are sometimes not there. The index I would give a B+. It is pretty good. The actual material of the book... is great. Some topics that are actually pretty dry, due to the writing style of the authors, is certainly bearable, where the more interesting parts of business law and the case studies are thoroughly interesting indeed. When I'm up at 1am studying, I save this book for last because it

doesn't put me to sleep like the others. I agree, the case studies and wealth of info in this book certainly make it a good read for anyone. Actually, there was some info in this book I read 3 days ago that helped me today (a part about consumer law).
