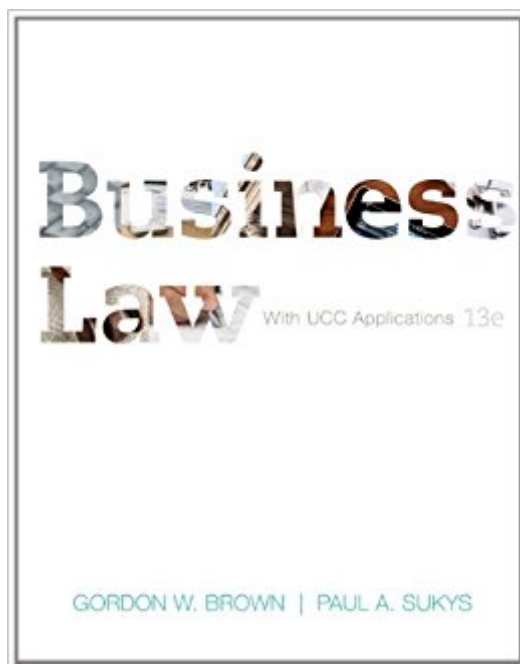

The layout of this book is difficult to follow. It is great that the key words are highlighted in blue and that in the chapter summary they are listed along with their page numbers but they really need a definition breakout with so much information. The wording is not as clear cut as it should be either.

I can't believe how much this book costs when it is littered with spelling and grammar errors. I like reading aloud so I can concentrate on stuff and I've noticed a ridiculous number of mistakes. This is supposed to be a college textbook, but it sounds like it was written by a group of high schoolers that didn't go back and proofread. I am convinced nobody proofread this book. On page 213, for example, it is discussing a TV, but when it goes to talk about it again, it called it a computer! Literally 3 lines up it says TV and now it calls it a computer. I was very disappointed with be quality of the book and I'm disappointed that professors are making us use poor quality books for class. It would have been a great book if it appeared more professional.
