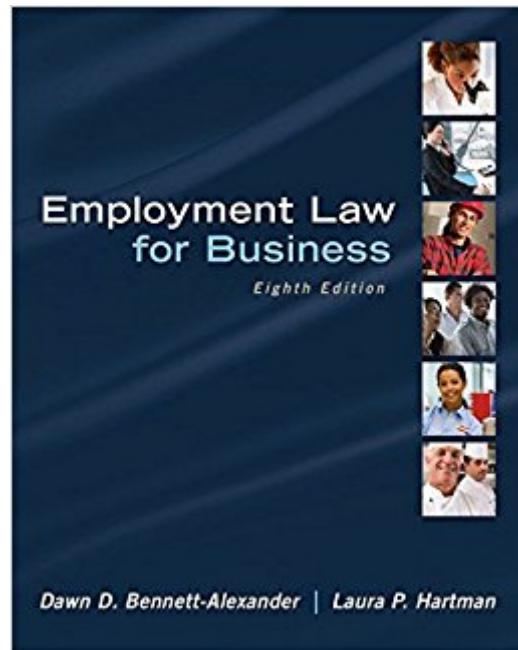

I rented this book for a class that I had, and I really didn't want to return it. This book is great for literally anyone that is an employee (not a contractor). It is very informative and covers every area of employment law. It would also be a great resource for employers that want to make sure they are compliant. I will look to buy the international version of this book in the future.

This was not a very well written book. It was written more as a novel than a textbook. It was hard to decipher the main point that were supposed to be made. The main topics and subtopics were not delineated, as they are in standard textbooks. The writer's tended to go off on a subjective tangent which made some chapters much longer than they needed to be. A prime example is the gender affinity chapter. This chapter was almost 50 pages and it could have been reduced by at least 10 pages. Even the PowerPoint slides that the professor had were as he put it "redundant".

This was supposed to be a text book for an HR class but it's more fitting for a law class. 99% of what the book covers are law cases and nothing covered was from an HR perspective. A lot of legalise that I had to look up terminology for. I would not recommend this as a text book for an HR class. It would be more appropriate for a law class. Also the book was way too expensive.

A textbook is a textbook. I don't necessary love the reading, but the quality of the book is excellent and the text was well written.
