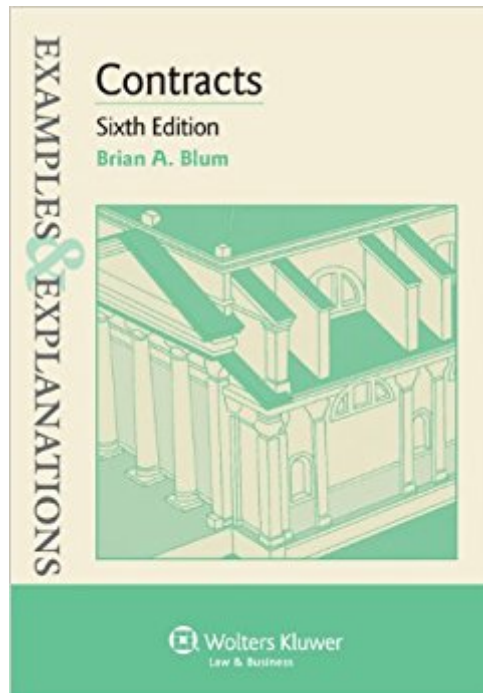

This text provides in-depth discussion of Contracts. It is probably more thorough than your professor, but you can pick and choose which sections you want to read. It's not set up so that you must read the entire thing front to back. They have a case index that can be useful if you want to see what you're reading is in the book. Additionally, the general index in the back is extremely helpful. My only critique is that one subject might be discussed in multiple sections of the book, causing you to flip lots of pages and speed read quite a bit. However, it's a useful tool if you find yourself to be struggling with contracts!

Drastically helped me with my Contracts I & II courses in my first year of law school. If you are studying for an exam this will go a long way in helping you. Also a great compliment to whatever text books you are using in your class to just help you understand the fundamentals of a contract better.

This book has been absolutely wonderful. Contracts is a challenging class, but this has been very, very helpful. I recommend it if you are struggling with contracts because it breaks it down into manageable sections.

Approaching final exam time, I really just felt like I needed to hear the content of the Contracts course from a different perspective. This book broke everything down and gave some helpful recommendations as to approaching the issue. As with all supplements, I would suggest renting from a library since you may not end up using it much, or at all, before finals week and may not want to pay for a book that you can't return at the end of the semester.

If you are studying for the FYLE this is a must have. It cuts through a lot of confusion and gets to the point. Furthermore, the examples are very close to some of the fact patterns on the exams I have already taken. I wish I would have had this at the beginning of 1L.
