The Good:What these laminates do better than nearly any other resource is to give you a general overview and guide so you can understand where the material is going. Similar to the artist's technique where you have to create a vague rough sketch to understand proportion and relevance, these allow you to understand the significance of minutia and detail in the bigger schematic. Also great refresher if you are return after a long time away and your own notes don't make sense anymore.The Bad:The Contracts laminate is one of the weaker of the series. The guides cannot replace the actual text or class material, though of the entire series Constitutional Law and Criminal Procedure come closest.The Ugly:For those gunners out there, the laminate surface also makes these perfect to buy a second set to keep in the can for those "first thing in the morning" study

sessions.

Quick study Contracts is great for first year law students. It gets to the meat of the issue without having to search for it. Like Cliff notes for Contracts.
