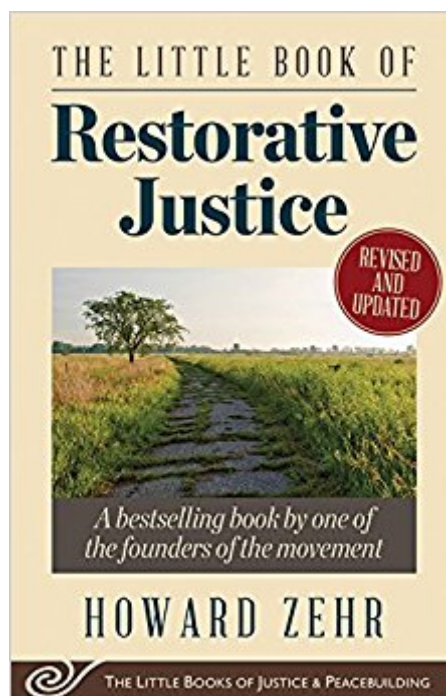

The principles of RJ can be used in all types of conflict and offense, from parenting, to school discipline, to adult conflict in the workplace and off course as an alternative to the traditional way of handling criminal offenses. I do wish there were

some examples of the encounter conversations or discussion on how long these processes can take, but it would have been a much longer book then. This book does a good job at staying focused on explaining the foundations and guiding principles of RJ instead of Telling people how it should be practiced.
