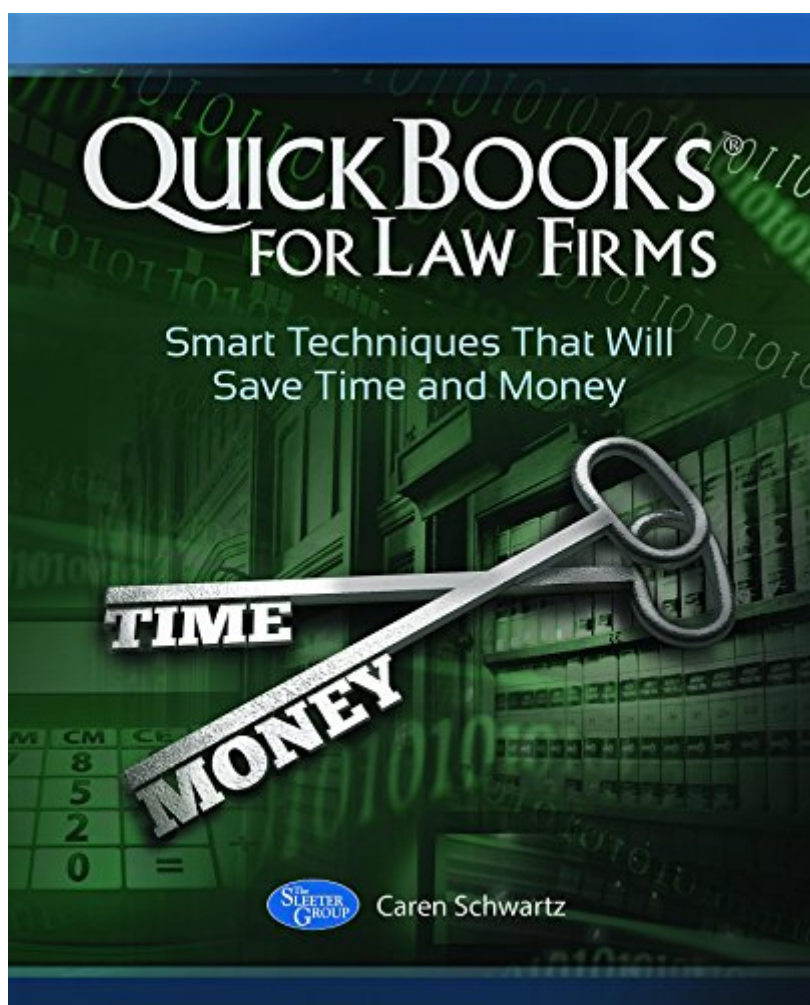

This book should be titled "How to Setup Quickbooks." There is virtually NO helpful information in this book that would assist an attorney or small law firm effective USE Quickbooks on a day to day basis. Items that aren't discussed at all: 1. Best workflow practices for entering firm expenses (i.e., methods for staying on top of accounting) 2. How to reconcile accounts, particularly IOLTA accounts. 3. How to change EXISTING Quickbook setups to incorporate setup suggestions in the book. 4. How to run reports on client's outstanding Items that are discussed, but don't offer any practical help: 1. How to effectively account for "soft costs." The book offers advice for setting up an "Item" for tracking soft cost expenses, but doesn't cover at all how you are supposed to categorize the reimbursement funds when they are received. All in all, this book includes SOME very basic information - but not enough to effectively allow a attorney to use Quickbooks on their own. It certainly doesn't cover the particular needs of lawfirms very well at all.

A very well written book and easy to follow and understand. Caren also makes sure that we understand the legal terminology and how it applies in QuickBooks. I really appreciated the many QuickBooks screenshots she included in her book because it made it that much easier to follow along and see how transactions and reports were created and later used (especially great for us visual learners).

I did find some useful tips in this book but I expected a lot more depth and detail. The author spends a lot of time on basic Quickbook functions which a regular user already knows. I bought this because I thought they were going to provide a lot more information specific to law firm accounting. I skimmed through more than half the book looking for the meat. The book is easy to read and clear. On my iPad it was very handy that I could tap on the illustrations and then expand them to read them easily.

As I read the book to see what QB would offer "in comparison" to the billing program my law firm currently utilizes, the book stated that it would only be useful if the reader already has the actual program. So, hint: don't use the book to "determine" if it would be helpful to "switch" from another program to QB. Guess it would be better to speak with sales to that end. That said, the book is written in clear, easy to understand language.

I have no prior experience with Quickbooks and this book was very easy to read and a great guide

to getting things done in Quickbooks! Great purchase!
