

When I paid the price I did for this book, I was expecting a pretty good-sized book. The book I received was small and thin. I spent a pretty long time staring at it going "really???", feeling completely robbed, wondering how the publishers sleep at night, etc etc. Once I got over that, I've been happy with the content of the book.

What I find useful: the phrasebook offers translations in specific areas of law - such as contracts, bankruptcy and business law, which have been wanting. Unfortunately - it's too short and some of the translations are literally translations and fail to communicate the concept. I'm hoping the ABA will expand the phrasebook and work with legal scholars from Mexico, Spain etc. to develop more accurate translations.

This was purchased as a gift for a co-worker. It is not really a book but more of a pamphlet.

For someone like me, who speaks Spanish fluently already but is looking to expand their vocabulary into an area that you might not have had the chance to delve into much before, this book is **PERFECT!** Very helpful and useful, you'll be happy you purchased it!

For the money, this 104 page 5x8" dictionary is the most expensive Spanish-English dictionary I have ever purchased, and I wouldn't recommend it. It is divided into chapters based on different areas of law. I am a criminal attorney, and it contains ten pages of criminal law terms. Ten. Truly the most lame purchase I've ever made. I'd be ashamed to admit it, but I wanted to warn others.

It is a tiny book, easy to carry around, with everything you need. I am proficient in Spanish, but don't get to use the language that much any more. This definitely helps refresh my memory.
