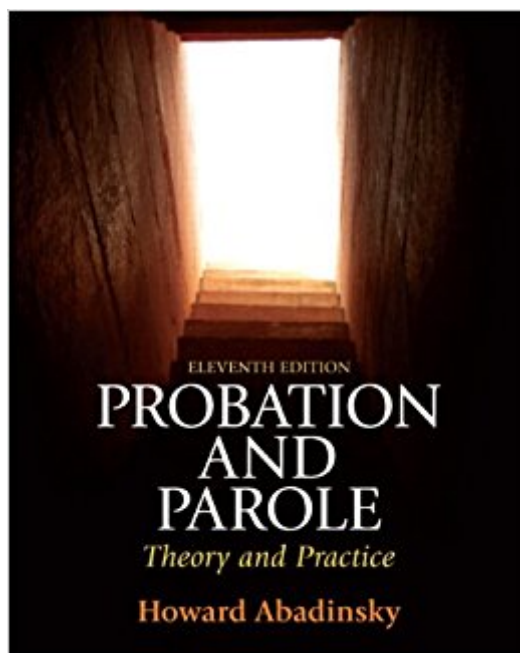

The book itself is divided into chapters whose topics are flooded throughout the entire book. There is no order whatsoever. Within a paragraph, there are several listings of states enacting different things at different times which do not correlate in any way from one sentence to another. There is no organization within the text and the author has evidently never heard of the chronological concept. This is a poor text and if you are taking a course which lists this book as a mandatory text, find a different university.
